
Unit A:


Unit B:



Unit C:

Theme: No Good Deed Goes Unpunished


Essential Question: Do traits like altruism and philanthropy allow a human to advance themselves or do these attributes actually limit humans potential to improve themselves?

*Making the Grade (Article)


*I am not a Babysitter (Article)

*Wealthy Teen (Satirical Article)


*A City upon a Hill (Essay/Speech)
