

**Special Called School Board Meeting
Tuesday, August 14, 2012 at 6:00 P.M.
Fayette-Ware High School – Library**

1. Call the meeting to order.

The meeting was called to order by Mr. Bryon O'Brien, Chairman of the Board at 6:00 P.M..

2. Establish a Quorum.

A quorum was established with the following members present; Linda Barton, Robert Redditt, Marandy Wilkerson, Bryon O'Brien, Ronnie McCarty, David Barnes, Sally Spencer, Patricia Burnette and James Teague, Interim Superintendent. Evangeline Shaw was absent.

3. Approval of Agenda.

Mr. Barnes motions to approve the agenda.

Mr. McCarty seconds it.

Mrs. Wilkerson wanted to know who called this meeting and why after the Board authorized Mr. Teague and his team to move forward and go back to the old schedule and old bell times and utilize them as efficiently as possible. She wanted either the Chair or Mr. Teague to respond.

Mr. O'Brien stated that Mr. Teague called him yesterday around 10:00 A.M. that he had some information concerning the transition. The Executive Committee decided that we would have a meeting. He stated that he did not think that was a decision the Executive Committee needed to make that it was a decision the Board needed to approve.

Ms. Burnette wanted to know if they needed to discuss some aspect of the old transportation policy and if so is that why we called a meeting and needing to discuss it.

Mr. Barnes stated we have approved the agenda.

Mr. O'Brien stated that we did not. He stated that Ms. Burnette had something to say.

Ms. Burnette stated that Mr. O'Brien stated that Mr. Teague had contacted him and had some questions or clarifications. Are we meeting for some clarifications on an old policy that the Board has just approved?

Mr. Teague stated that last year in August, Fayette County Schools used 52 buses and 7 Special ED buses on the first day of school, this year we used 48 buses and 6 Special Ed. buses, which was the max we could use. He stated that we were 4 buses short from the General Ed. and one bus short from Special Ed., so we are 5 buses short to reinstitute last year's routes. He stated that was the purpose of this meeting to see if we could fix that problem and remedy that.

Ms. Burnette wanted to know if they were going to discuss the shortage of 5 buses and not a motion to change the policy that was just voted on.

Mr. Teague stated that the reason he asked for this meeting is that we were 5 buses short of being able to run last year's route. This is one of the problems.

4 – Yes 2 – No Ms. Burnette and Mrs. Wilkerson voted no.

Mrs. Shaw was absent.

Motion fails.

Mr. O'Brien stated that we voted on the motion and it failed.

Mr. Barnes stated then we are done.

Mr. O'Brien stated unless the agenda is modified to where it could be approved.

Mr. Barnes stated if there is no motion on the table, there is no discussion.

Mr. Redditt stated that he makes a motion to adjourn and Ms. Burnette stated that she seconds that.

Mr. O'Brien stated that we have a motion to adjourn, then we are done.

4. Discussion and approval of Transportation and Bell Times.

None. Board Members did not get past approving the agenda.

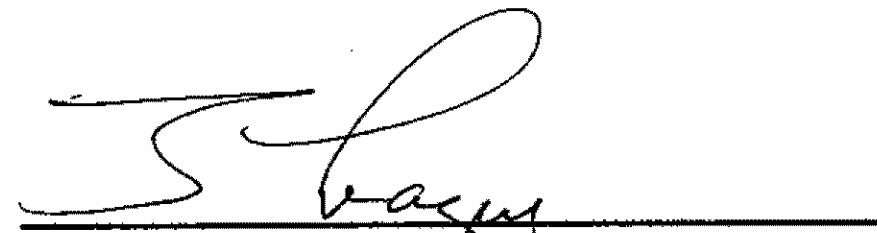
5. Adjournment.
